7. Core Professional Skills Training

The California Planning Roundtable (CPR) is interested in assisting the Chapter with providing core professional skills training for planners, particularly those newer to the profession. Brooke Peterson, past Chapter President, went to the CPR retreat in 2014 to discuss a possible partnership with the Chapter. CPR members were very supportive and the first step was to propose a series of such sessions at the 2015 Chapter conference and then assess the next steps.

CPR would like to continue to build a stronger bridge with the Chapter and define a role for CPR in terms of professional training; professional training seems to be a natural fit given the breadth of expertise among CPR members. They are now exploring possibilities and wanted to get input from the APA Board on what they see are the next steps, such as training sessions we might do outside of the annual conference. They are focusing training on AICP core competencies for entry- and mid-level planners, and filling the niche on those topics that are not commonly covered in graduate urban planning programs, such as strategic thinking, organizational skills, time management, dealing with hostile environments, and political acumen.

They felt that a three-hour dedicated workshop at the conference on core professional skills could be a guaranteed session sponsored by CPR/APA. The subject matter would vary from year to year. In addition to these workshops at the conference they'd also like to coordinate with the section boards and PDOs to sponsor and organize similar workshops at various locations throughout the state that would be eligible for CM credits. They're also looking for some funding to cover incidental expenses for these section-sponsored workshops (from the sections and/or the Chapter).

I think this is a great opportunity to take advantage of the resources CPR members have to offer and to provide workshops at the section level where they may not be enough or in some cases, none at all. I'm requesting that you reach out to your section boards to get their feedback on this opportunity. If you all are okay with me contacting your chapter directors directly, I'd like to do that. I'd like to give them a heads up and then have you individually discuss this at your next board meeting. Once I get some feedback I'll report back the Chapter Board and CPR.

Task Force. Please let me know if you're interested. A new exam outline is expected to be released in July. The expected date for the roll out of the new exam is May 2017.

The other important topic of discussion was related to CM credits. National is now going to allow AICP members to log up to eight CM credits for volunteer work, such as that done as part of a planning assistance team. Persons requesting such credits will be required to view a web tutorial prior to logging them so it's clear that the activity they're seeking credit for qualifies.

10. Proposed AICP Candidate Pilot Program – Request For Your Assistance

The AICP Commission requests your help in providing and soliciting feedback on a proposed <u>AICP</u> <u>Candidate Pilot Program</u> that will foster students' and other emerging professionals' career development and clarify the path to certification.

The proposed AICP Candidate Pilot Program is designed to achieve several key goals:

- Foster interest in planning as a career;
- Introduce students and other emerging professionals to the ethical and professional standards that are the foundation of the AICP credential:
- Provide professional development opportunities as students and other emerging professionals begin and progress in their careers;
- Establish a clearly defined path to AICP certification; and
- Maintain—and even enhance—the value and integrity of the AICP credential.

Features of the proposed AICP Candidate Pilot Program include:

- Eligibility will be limited to students in and graduates of <u>Planning Accreditation Board</u>-accredited programs (both graduate and undergraduate).
- AICP Candidates will be eligible to apply for the AICP Comprehensive Planning Exam one year earlier than non-AICP Candidates.
- AICP Candidates must participate in a modified <u>Certification Maintenance</u> program and log a minimum of 16 CM credits during their candidacy.
- AICP Candidates will commit to the AICP Code of Ethics and Professional Conduct.
- AICP Candidates will be authorized to use "AICP Candidate" on correspondence, resumes, and other references.
- Participation in the AICP Candidate Pilot Program is limited to five years.
- AICP Candidates may be matched with a mentor to provide support in applying for and preparing to take the exam.
- The AICP exam application fee will be discounted (\$15 instead of \$70).
- AICP Candidates will receive an AICP exam application toolkit.

Input is needed to create an AICP Candidate Pilot Program that will achieve the Commission's aforementioned goals.

The Commission wants as many people as possible to be aware of this proposal and have the opportunity to comment by completing a brief online survey.
