Mr. McNulty is the director of RECON's Central Coast office in Goleta and a project manager with extensive public and private sector planning experience on the Central Coast and in northern California. Mr. McNulty has managed complex projects involving general, coastal, and community plans, and participated in regional planning efforts. Mr. McNulty is highly experienced in interagency coordination, working with decision-makers, and public outreach and is an expert in land use policy, including housing, economics, transportation, conservation, urban revitalization, energy, infrastructure, restoration, and CEQA/NEPA compliance.

Previously, Mr. McNulty was with the County of Santa Barbara Planning and Development Department in long-range planning where he managed comprehensive plan updates, housing element updates, and EIRs and reviewed projects. He also teamed on regional plans addressing land use, housing, transportation and sustainable communities. Prior to coming to the Central Coast, Mr. McNulty was a private sector planner providing contract planning, project review, and CEQA and NEPA compliance services for Placer County and the cities of Sacramento, Auburn, Colfax, and Colusa. Mr. McNulty was formerly a planner with the Sonoma County comprehensive planning division and an economic development specialist with the City of Sebastopol.

Tess joined Santa Barbara County in 2017. She is a planner in the Development Review Division of Santa Barbara County, where she manages a variety of cases (recent projects include Tentative Parcel and Tract Maps, Development Plans, Conditional Use Permits, and General Plan Amendments such as the Tajiguas Landfill and Highway 101 expansion projects). From 2014 to 2017, Tess grew from a Planner I to a Planner III in Ventura County, and particularly enjoyed managing Ventura County's Land Conservation Act Program. She graduated from UC Santa Barbara with degrees in Environmental Studies and English and pursued a Master of Arts in International Environmental Policy from the Middlebury Institute of International Studies. Her first planning position was with the City of Pacific Grove, where she worked on Long Range planning projects, including their Urban Forest Management Plan and Urban Greening Grant. Outside of Planning, Tess has worked at the U.S. Department of State in the Bureau of Oceans, International Environmental, and Scientific Affairs and was a U.S. Fulbright Fellow in Cyprus where she researched irrigation techniques and water conservation practices and policies in the agricultural sector. Tess has been the APA Santa Barbara Subsection Director since 2016 for the Central Coast Section of APA. Tess was the Membership Inclusion Officer for the Central Coast Section of APA from 2014 - 2015.
