He has coordinated online interactive engagement tools, facilitated community workshops and design charrettes, and created visually appealing and easy-to-read maps and other graphics.

Jonathan is Circulation Manager with Facebook in Menlo Park and teaches part time for the Urban and Regional Planning Department at San Jose State University. He holds a BS in City and Regional Planning from Cal Poly, San Luis Obispo.

He previously served as Merchandise Chair and volunteer for the mobile workshop committee for the 2015 California APA conference planning committee. ## **Orientation Tour Coordinator - Bob Zimmerer, AICP**

Bob has 13 years of professional planning experience: ten years at the local, municipal level and three at the federal level. His local, municipal experience is wide-ranging, as he was the sole planner for a suburb and thus wore a lot of "hats". For the last several years, Bob spent his time working under contract to the U.S. Department of Transportation supporting the Federal Railroad Administration (FRA) with monitoring and technical assistance of FRA's grantees and their capital projects. His role is to help with grant management oversight, especially with grants to the California High-Speed Rail Authority.

Bob served as Illinois Chapter Treasurer from 2011 to 2013. This is an elected position and is the third most prominent position in the chapter's leadership, so he knows how to represent a chapter/section and how a successful event like an orientation tour can leave a lasting impression for the host city, section, chapter, and APA. Bob's first substantial conference effort was working on a variety of administrative and logistical elements with other volunteer planners as Chair of the Hospitality & Administration Committee for the 2009 Upper Midwest Planning Conference. (Upper Midwest means the four states of Illinois, Wisconsin, Minnesota, and Iowa.) Bob led all administrative and logistical tasks for an 800-attendee professional planning conference that consisted entirely of mobile workshops (other than plenary sessions). In 2013, Bob served as one of approximately 30 guides for the orientation tours during the National Planning Conference in Chicago where he learned how much preparation and improvisation is necessary to deliver a great tour; from driving the tour route practicing one's "lines" to quickly building rapport with other guides. In 2015, Bob served as a member of the Conference Host Committee (Programs) for the APA California Chapter Conference in Oakland; this allowed him to become familiar with APA California and the Northern Section.
