# ACTION ITEMS FROM THE BOARD MEETING

# CALL TO ORDER

President Julia Lave Johnston called the meeting to order on Friday, December 18, 2020 at 3 pm.

## II. APPROVAL OF CONSENT ITEMS

The Board moved, seconded and passed to approve the consent items: 2021 Appointed Board Members, Chapter Bylaws Update, Section Bylaws Template and the November Financial Report. *Unanimous vote*.

#### III. ACTION ITEMS

**2021 Final Draft Budget Approval:** Derek Wong provided the Board with a detailed review of the final draft of the 2021 Chapter budget, which was first presented to the Board for discussion in October. Typically, a draft budget is presented at the September/October Board meeting every year for approval by the Board with updates made in January after final year income and expenses are finalized. However, given the uncertainty of both the virtual conference profits and the subvention check amounts in September due to COVID-19 impacts, the draft budget was put on hold until the final profit numbers from the 2020 conference and the third quarter subvention check, the Chapter's two largest income sources, were known. VP's were also asked to review their current budget line items and let Sande George and Derek know if there would be any budget changes or new projects under their portfolios that would require funding in 2021. Derek and Sande then worked with the Chapter's bookkeeper, Laura Dee, to prepare the final draft presented for approval to the Board today.

Julia Lave Johnston and Ashley Atkinson let the Board know that they have been spending time going through each of the Chapter contractors' Scope of Services to make changes and updates as needed. Contracts for the contractors are also being reviewed at this time and there may be changes made to the final draft budget at the January Board Meeting to reflect contract negations. While discussions are ongoing with most Chapter contractors related to their Scope of Services and contract, the Board was provided an opportunity to review the Scopes of Service for both the Executive Director and the Chapter Lobbyist, which have both been finalized.

The Board moved, seconded and passed to approve the final draft of the 2021 Chapter Budget. The final draft will be brought back to the Board in January for final approval. *Unanimous vote*.
